The finest international insolvency Faculty and Delegates in the world will convene in Paris on June 21–22, 2012 at the III's 12th Annual Conference. The III Paris Conference will feature reports and analyses of the most important current international insolvency issues and controversies described by speakers who are recognized as preeminent in their field from countries around the world.

COUR DE CASSATION (SUPREME COURT OF FRANCE)

The Conference venue will be the historic chambers of the spectacular Supreme Court of France. The Cour de Cassation was instituted during the French Revolution but its roots go back to the middle ages when the King's Courts gave relief to those who felt they had been denied justice in lower courts. From the 16th Century to the time of the French Revolution, the Palais du Justice in which the Cour de Cassation is located was the seat of the Parliament of Paris. The Cour de Cassation is located adjacent to Paris' magnificent Notre Dame Cathedral (completed in 1345) and is close to the famed Sainte Chapelle which was built by King Louis IX (1226–1270) and features the oldest and loveliest stained glass windows in Paris. Also nearby is the Famous *Conciergerie*, a prison facility in which, during the French Revolution, Queen Marie Antoinette was imprisoned as she awaited her final journey to the guillotine. The Cour de Cassation is a French national monument and is subject to military security which must be observed by all visitors. We are very fortunate to have this historic venue for our Conference.

CERCLE DE L'UNION INTERALLIÉE

The III's famous Legendary Paris Dinner will take place on the evening of Friday, June 22, 2012 at one of the most exclusive, prestigious and historic private clubs in Paris. Our venue will be the *Cercle de l'Union Interalliée* which is an historic mansion adjacent to the residences of the United States and British Ambassadors on Paris' famous "Embassy Row" and close to the Elyseé Palace, the Official Residence of the President of France on Rue du Faubourg Saint Honoré. The Union Interalliée was founded 1917 under the auspices of Marshall Ferdinand Foch and is within walking distance of the Conference hotel. Refreshments will be served in the Estate's gardens (weather permitting which it surely will) and the Legendary Dinner will be held in the fabulous Salon Marc de Beaumont Room of the Club. The Legendary Dinner will be a glittering Parisian event and is not to be missed.
